The Norwich Businesswomen's Network was set up in 1991 to promote business and social contacts between local professional and business women who are decision makers within their organisations.

Membership is open to women running their own businesses and professional and business women working for larger organisations in senior management positions.

The group meets for lunch on the second Wednesday of each month at a variety of venues. During lunch there is a 15 to 20 minute speaking slot, which provides an opportunity for members and outside speakers to give presentations and discuss a wide variety of business, community and personal interest issues.

We are also delighted to support several charities each year. These are usually local, but there are occasions when our support is global.

Booking forms providing information on venue, price and speaker are sent out to members approximately three weeks before each lunch.

The current membership fee is £40 per annum. Membership is for the individual and not transferable. Non-members are welcome to attend up to two lunches as a guest of an existing member, after which they will be required to apply for membership should they wish to continue attending.
